No opposition, no abstentions. <u>Bob was elected as the new Chair, beginning 1/1/23</u>. (3 yrs)

Dan Sigouin agreed to stay on as <u>Vice Chair</u> for a year, if needed. Jennifer stated that a time limit forces action, whereas an open term eliminates the need for any further action. We can suspend the rules and extend his term, or we can just <u>leave the Vice Chair position</u> <u>vacant</u>. The consensus was to <u>leave the Vice Chair position open for now</u>. We have made four motions today before the additional members arrived. Randy Long, Steve Berger, David Schaefer and Deanna all agreed. Ed moved, seconded by Harry to accept the four motions from earlier this morning. No opposition, no abstentions. <u>All previous Motions are accepted</u>.
