# 6. Secretariat Report - IEEE - Jennifer Santulli

6.1 - Status of C63® published standards

**6.1.1 Fourth Anniversary standards**

**6.2 – Status of PINS and PINS-C** (<u>currently posted list</u>) Steve Jones could not state what the FCC policy is on citing corrigendum, which correct mistakes in the Standard. Discussion ensued. The Chair noted that if we petition the FCC, it should come from the Main Committee after discussion.

Harry asked why C63.24 has a PINS from 2001, but new work has begun on the document. The previous re-affirmation effort had comments, which cannot be addressed in a re-affirmation. Mr. Heirman noted that

we have begun looking at the document and will seek a PINS-C when we feel that we have stabilized the joint work with IEEE-473 on the next version.

**7. Subcommittee reports** (Brief written reports to include actions needed by C63®, and items of particular interest during SC meetings).

7.1. SC1: Measurement and Instrumentation - Chen - The report was shown.

Mr. Chen move to accept the Title, Scope and Duties as shown. No second was needed.

The motion carried unanimously. Mr. Chen showed the PINS C63.4 corrigendum r1

20180320 draft PINS. Mr. Chen moved to accept the PINS as shown, no second was required. Mr. Griffin voted no. Mr. Moongilan abstained. The motion carried by voice vote.

#### From the Steering Committee minutes:

Jennifer will check with ANSI regarding the ANSI Essential Requirements regarding Interpretations process. Mr. Berger felt that we could model our procedure after the FCC complaint process, requiring the complainant to try to work with a WG Chair on a resolution. Mr. Berger moved to allow the SC Chair and WG Chair to attempt to resolve the Interpretation question informally. Mr. Hare seconded. Don Heirman opposed. The motion carried.

Mr. DeLisi moved that the Steering Committee recommend to the Main Committee that we be allowed to <u>temporarily postpone answering Interpretation Requests</u> while our C63 procedures are being reviewed. Mr. Sigouin seconded. The motion carried.

Discussion ensued. Mr. Hodes noted that our last change in procedures, written under Dean Ghizzone, took many months for ANSI to approve. He questioned the wisdom of this postponement. Mr. Sigouin noted that the procedure for Interpretations was embedded from another document into the current procedures. Interpretations will come in to the Secretary, who will acknowledge receipt and inform the requestors that we have postponed replying to requests for six months. Harry noted we have several Interpretation responses in process, which will be finished. Only new requests would be affected by this proposed postponement. Mr. Griffin thought that the IEC had no particular process to address "interpretation sheets." A vote was called. Mr. Hodes opposed. The motion to postpone answering interpretation requests for six months while our procedures are being reviewed carried.

- **7.2. SC2: Definitions Shellman -** The <u>report</u> was shown. Mr. Shellman moved to accept the Title, Scope and Duties of SC2. The motion carried unanimously. The cut-off date for submission of new definitions for inclusion in the next C63.14 draft will be August, 2018.
- 7.3. SC3: International Standardization Heirman The report was shown. We are moving parts of our C63.16 Recommended Practice for ESD into IEC-TC-77 and into the next IEC 61000-4-2. The SC3 Membership Roster was shown in a document. Mr. Shellman was listed as a new member. The liaison members were shown. Mr. Heirman showed the SC3 Scope in a document. AI-53: Don will report any movement of C63 material into a US National committee. The SC3 Duties were shown. Don moved to approve the Title, Scope, Duties and Membership of SC3. No second was needed. The motion carried unanimously by voice vote. The Standards comparison tables were shown. AI-54: Don & Jerry to add C63.25.1 and C63.25.2 to the comparison tables. Work that is being considered for input to CISPR included a tolerance table, equivalency of site validation and a repeat measurements approach that was shown. Work in progress was reviewed. AI-55: Don to add a column to SC3-Table 2 to list which target committee the report is being sent to.

- 7.4. SC4: Wireless and ISM Equipment Measurements DeLisi The report was shown. The Title, Scope & Duties were shown. New members were added as shown in 5.5 above, now up to 23 members. Mr. DeLisi moved to accept the SC4 Title, Scope & Duties. The motion carried unanimously by voice vote. Progress on individual Standards was reviewed.
- 7.5. SC5: Immunity testing Hare The report was shown. The Title, (amended) Scope and Duties were shown. The Membership roster was shown, with one new member. (Ross Carlton) Mr. Hare moved to approve the Title, Scope & Duties as amended. No second was needed. The motion carried unanimously by voice vote. Al-56: The current edition of C63.9 uses arbitrary waveforms in digital form. Mr. Hare and Mr. Berger are to work with IEEE and the C63 Chair to determine how best to distribute these waveform files. Individual Standards activity was reviewed. The C63.16 recommendation report will be made part of the SC5 Minutes. C63.24 on in-situ RF immunity was discussed, with a joint working group formed with IEEE-473 on Site Surveys.
- **7.6. SC6: Laboratory Accreditation Long -** The <u>report</u> was shown. The Title, Scope, Duties and Membership roster was shown. Doug Kramer was added and both NIST/NVLAP members were removed. Tim Rasinsky (NIST/NVLAP) will apply for membership later. Mr. Long moved to accept the Title, Scope, Duties and Membership. The motion carried by voice vote. Mr. Long noted that ANAB in now recognized by the FCC for non-RMA countries. Perry Johnson Lab Accreditation was invited to apply for membership.
- 7.7. SC7: Unlicensed Personal Comm. Services Bazhanov The report was shown. The Title, Scope, Duties and Membership roster was shown. Mr. Bazhanov moved to accept the Title, Scope, Duties and (amended) Membership roster. The motion carried by voice vote. Progress on individual Standards was shown. An initiative to bring in more members was proposed.
- 7.8. SC8: Medical Equipment Testing Berger The report was shown. Mr. Berger felt that they had a deficit of medical equipment manufacturers and has begun outreach efforts. Discussion of that outreach effort ensued. The FDA has noted that users of Bluetooth in medical applications were having some interference problems. C63.18 and C63.19 progress was discussed. He reported that up to 80% of wireless handsets deliver a negative experience for the hearing-impaired user. There was an understanding of how to fix the test for this deficit, which is now under discussion. The Title, Scope, Duties and Membership roster was shown. Mr. Berger moved to accept the Title, Scope, Duties and Membership roster. The motion carried by voice vote.

#### 8. New Business

C63.4 and C63.4a - Mr. Heirman noted that C63.4a is Annex D in the previous 8.1 Standard. Our intention was that C63.4-2014 now is modified by this Annex. This annex is also included in the next 2019 edition of C63.4. Mr. Hodes reported that it allows labs to test products taller than 2m, up to 3m or other heights. We've always had requirements for NSA for tall products, so this is a great simplification to make testing easier. Harry discussed a motion to petition the FCC to adopt C63.4a. Mr. Hodes moved to have the Main Committee submit a petition to the FCC to adopt C63.4a as normatively incorporated in C63.4-2014. The motion was seconded by Don Heirman. Mr. Griffin proposed a transition period of two years be included in our petition to the commission. Discussion of the practical effect of this petition ensued. (only covers products over 2 meters high) Mr. Hoolihan thought a letter from the Chair may suffice. Mr. Hodes noted that he was told by Mr. Jones that they wanted a petition. Mr. Heirman thought we could approve the text in such a petition by electronic ballot. The motion carried unanimously by voice vote. AI-57: Mr. Heirman and Mr. Hodes will draft the FCC petition text for C63,4a and submit to the Chair for review and recirculation to the Main Committee for review and electronic ballot

approval.

- **8.2** Patent Issues Art Wall Art noted that we have two open patent issues, so he can only discuss general patent issues, not specific ones. A manufacturer may have a patent and if other manufacturers want to incorporate the content, it causes a patent dispute. In C63.19, we should not mention the patent number in the document. Mr. Wall showed the ANSI-ASC-C63® Generic Statement of Assurance from our website. He noted that the WG Chair must ensure that any potential patent issues are raised at the beginning of a meeting and that the holder is referred to the Secretariat so she can contact ANSI and the IEEE legal department.
- 8.3 MEC from IEEE Lisa Perry Lisa Perry of IEEE discussed Mandatory Editorial Coordination (MEC) features. She looks at the Normative References to see if they are cited in the text. It's a quick review to try to clear up problem areas proactively. No review of syntax or wording is included. Mr. Heirman noted we are becoming more careful in our use of "modal verbs" such as shall/should. Mr. Berger asked how he could get an authoritative opinion on the use of the IEEE style guide. Mr. Hodes asked what degree does the Guide become mandatory. "Shall" was the most important verb, she noted.

Lisa discussed IEEE amendments, showing tracked-changes. This became a problem, as these changes obscured the final text. Moving forward, IEEE will only show the clean version. Mr. Hoolihan thought that an amendment should be 2-3 pages at most. (C63.4a was over 70 pages long) Mr. Hodes pointed out that the amendment was not available in clean form. He had complained to IEEE that the Amendment was unreadable and was ignored. Ms. Perry responded that clean versions will be available, and a clean unofficial version was also made available to Mr. Hodes.

# 9. Other Administrative Matters
