2. Approval of the Agenda

2.2. Balance of Agenda –Chair

2.2.1 Presentation of patent slides—(Secretary) The IEEE patent slides were shown by the Secretary. (Attached as filename: <u>pat-slideset.ppt</u>) None in attendance identified any patent issues.

3. Membership report- Hoolihan

- **3.1**. Membership applications Mr. Hoolihan reported that the Membership Committee recommended membership changes as shown in the attached document. There was no discussion, a vote was taken and the report was accepted by voice vote. It is attached as filename: FIFTH-DRAFT Membership Organization Clarification[1].doc
- **4. C63**® **Draft Standards Status Reports by SC chairs or WG chairs** (standards status matrix almost ready for posting by Ed Hare) Attached as filename: C63 Status Template 4 21 09.xls
 - **4.1. C63.2 EM Noise & Field Str. Instr.** (approved) Mr. Heirman reports that the original ballot from three "secretariats" ago at IEEE was lost. The secretariat used the current ballot, which was approved by ANSI, and in the future the ballot will be archived on the web site for use by the Chair and secretariat. A normative annex was added covering CISPR.16-1-1 as the primary reference standard.)
 - **4.2. C63.4 Publication** –published; Mr. Heirman reports that this Standard was published 9/15/09 and is now available for sale on the *IEEE Store* website. A Standards Status PPT was shown, attached to these minutes as filename: <u>Heirman presentations for C63 Oct 2009.ppt</u>
 - **4.3. C63.5 Antenna Calibration revision** –Camell (underway) Mr. Camell summarized the draft sent back to the WG for additional work and new PINS, resulting in a new schedule for 2/2010 for a Subcommittee vote. His report is attached as filename C63 5 ref ant.doc
 - **4.4. C63.9 Immunity of Office Equipment maintenance** –Berger (current) Mr. Heirmanreports that the Standard is now being used for testing conference room audio equipment with a test level of 30V/m radiated electric field strength.
 - **4.5. C63.10—Wireless Devices publication** Mr. Camell reported that the Standard was published 9/10/09, that an active PINS is on file for the next revision, and that work on a revision is beginning with a large working group of 20-30 people. A C63.10 workshop is scheduled for 11/4-11/5 of 2009, shown in the attached document with filename:

 <u>C63_10Workshop_updates.html</u> Mr. Heirman showed the iNARTE home page and workshop brochure. Mr. DeLisi reported that 13 attendees are registered currently and that he seeks loaner devices for testing at the workshop. Mr. Heirman showed the workshop agenda from the iNARTE site.
 - **4.6. C63.11- Checklists sunsetting** Hoolihan (See SC6 discussion of lab checklists in 6.5)
 - **4.7. C63.12 EMC Limit setting -** Mr. Hare showed the attached slides, filename: <u>PINS C63.12.doc</u> which set the criteria for setting limits. A recirculation ballot is to be conducted by the secretariat with source material provided by Bob Hofmann. **AI-1**: Mr. Hofmann to provide source material for C63.12 recirculation ballot.
 - **4.8. C63.14—Definitions publication** Mr. Shellman reports a publication date of 10/23/09.
 - **4.9. C63.15 Immunity Meas. & Instr. publication** –Mr. Heirman reported the Status of this Standard with no repetition of IEC 61000-4-x Standards. Test equipment specifications such as amplifier compression and harmonic content for radiated immunity testing are addressed

- and publication is expected this year. (ANSI-BSR review underway) The report is attached as filename: Heirman presentations for C63 Oct 2009.ppt
- **4.10. C63.16 ESD Test Methodologies** Mr. Heirman reports that the old Standard was withdrawn but parts should be kept that are unique to this Standard, not in IEC 61000-4-2. It's not a formal project yet, but possible cooperation with the EOS/ESD Association on this Standard was discussed. Report attached as filename: <u>Heirman presentations for C63 Oct 2009.ppt</u>
- **4.11. C63.18 On-site Medical Device Immunity testing ballot**—currently withdrawn; Bob DeLisi reports that this revision is in current ballot and has comments that need to be resolved by 11/30/09, after which a recirculation ballot will be conducted.
- **4.12. C63.19 Hearing Aid Compatibility** (maintenance/current) Stephen Berger reports that 4-6 issues remain with strong interest in the 700MHz band. He expects a February completion date with balloting in March-April. Mr. Berger indicated that there is an expectation that the FCC will mandate the use of the 2007 version of this Standard by January 1, 2010.
- **4.13. C63.22 Guide for Automated EMI Meas.** current–Mr. Heirman reports that the Standard addresses the issue of validating that automated instrumentation is working properly and that it repeats manual measurements.
- 4.14. C63.23 Measurement Uncertainty draft -DeLisi (Guide under development) Emissions uncertainty (radiated & conducted) are addressed, Type A covers repeated measurements, Type B covers information largely taken from CISPR 16. AI-2: The Secretariat will coordinate with the IEC and CISPR the use of the IEC intellectual property. An uncertainty calculator spreadsheet is now included, but reporting requirements need to be finalized. A draft should be completed by the end of 2009. The Presentation is attached as filename: C63.23 Update _ Edition 1 October 2009.ppt
- **4.15. C63.24 On-site immunity testing status**—Mr. Hare reports that they are awaiting for the approval of the revision of C63.18 for medical environments, as C63.24 is for general, not medical, environments. The PINS document is attached as filename: <u>C63.24 PINS.doc</u> (about 3 months will be needed for completion)
- 4.16. C63.25 -Test Site Validation Requirements (in development) Mr. Camell reported that the Standard addresses time domain techniques and that an active PINS is on file. The Working Group is preparing a draft, with methods validated by measurements, which is targeted for release to the SC by late 2010. The ACIL rep, Bill Stumpf, will request info on any assistance that is required for these efforts by ACIL EMC Lab members, and his letter will be forwarded to the Secretary and the Chairman. PPT attached as filename: SC1 stds update Oct09.ppt AI-3: Bill Stumpf, the ACIL rep, will seek ACIL EMC Lab members to participate in site validation tests.
- **4.17. C63.26—Licensed Transmitter status**—Mr. Camell reports that an active PINS is on file and that the WG met twice with a large turnout each time. Work is just beginning with a roadmap developed and key tasks identified; now additional stakeholders are being sought. PPT attached as filename: SC1 stds update Oct09.ppt

5. New or proposed Projects

- **5.1. Status of active PINS**—(Secretary) Mr. Ramie was informed that the website was missing C63.25, and needed these other obsolete items to be removed: C63.19, C63.2, C63.4, C63.14, C63.5, C63.22, the PINS form, C63.17 and C63.9. The site is also missing C63.18, C63.24, and C63.12 **AI-4**: Secretary to remove old PINS and replace missing ones and the latest PINS form on the website.
- **5.2. Status of active PINS-C**—Secretary (one PINS-C from SC5 is up for consideration) **AI-5**: Ed Hare to modify PINS form currently on the site to become a PINS-C form. Mr. Hare should also install a separate website button to access the list of PINS-C forms on file in the public area.
- 6. Subcommittee reports (Brief written reports to include membership approval, actions needed by C63®, and items of particular interest during SC meetings; meeting summary to be sent to C63® Newsletter Editor.

- **6.1. SC1: Measurement and Instrumentation**-Camell reports that they have 14 members, one dropped, two requested to join, 6 active Stds, WGs working on two revisions & three new Stds, C63.5 targeted for 4/2010, C63.23 in 2010, others are long-term. New PINS for C63.5 proposed, "antenna" was removed from stakeholders area, SSM defined, text improved, a vote was taken, passed by voice vote. New membership requests were passed by voice vote. Welcome letter to go out to new members. DOC attached as filename: C63.5 ref ant.doc
- **6.2. SC2: Definitions** –Shellman reports the C63.14 membership roster with changes, presented the draft Std dated 23 October, 2009; new definitions requested; draft attribution process shown dealing with the holders of IP, such as IEC, etc. Summary Report prepared and delivered to Secretary and newsletter editor. PPT attached as filename: 20091022 ASC C63 SC-2 Report to Parent Committee (22 October 2009).ppt. AI-6: Secretary to inquire if "view only" capability (without copying) is possible on our site for our definitions in C63.14.
- **6.3. SC3: International Standardization** –Poul Andersen reports that the SC3 Secretary position is OPEN with no changes in membership. SC3 mainly consists of four SC chairs, (SC1, SC2, SC5, & SC8) as well as US technical advisors to the technical activities groups for CISPR & TC77. Current activities include analyzing ten C63 documents for possible harmonization with similar International standards. At their meeting, the SC added C63.24 and C63.18 for consideration. Lead persons for the ten documents need to be identified. Subject documents were shown and edited by the group. Filename: 2009-10 C63® SC3 Report.ppt
- **6.4. SC5: Immunity testing** Ed Hare reported on the status of standards, as well as one application for membership from Dave Schaefer from TUV America. Mr. Hare made a motion to add Mr. Schaefer to our membership, no discussion or objections ensued and the motion passed. **AI-7:** Application and resume to be collected from Mr. Schaefer by the Secretary for posting on the private area of our site. Steve Berger discussed a PINS-C proposal for interference mitigation in power utility facilities. Text in the PINS-C was modified, and a vote was taken on a modified PINS-C, carried by voice vote and attached as filename: <u>ANSI PINS-C Form Power Plant Control Immunity 091018.doc</u>
- 6.5. SC6: Laboratory Accreditation— Mr. Kuczynski reported that 14 members and 6 guests attended on 10/20/09. He moved to cancel the C63.11 PINS because of copyright issues and related costs. Mr. Hoolihan also reported that this commercial accreditation Standard would require significant copyright fees. A vote was taken and the motion to cancel C63.11 PINS passed. (C63.11 is now withdrawn and the Standard number is now available for reuse) A new PINS was presented by Mr. Kuczynski and he moved for approval of "Inter-lab Comparison for EMC Testing." A discussion ensued, his motion passed by voice vote. AI-8: Mr. Kuczynski is to revise the Scope statement for SC6 (http://www.c63.org/documents/sc 6/sc 6.htm) by proposing new text, to be supplied by Mr. Kuczynski. The PINS document is attached as filename: 091018 PINS on Guide for Proficiency testing SC6.doc
- **6.6. SC7: Unlicensed Personal Comm. Services**—Mr. Berger reported that over 50% of cordless telephones in the US use the UPCS band and the C63.17 Standard which is referenced by the FCC in their Rules.
- **6.7. SC8: Medical Equipment Testing** Mr. DeLisi showed the current SC8 membership roster and noted that a Secretary and Web Coordinator were needed. The Vice Chair (Mr. DeLisi) is currently acting as Chair. C63.18 is in comment resolution with recirculation balloting to follow. C63.19 will be ready by March 2010; an FDA report was shown as well as a IEC SC62A MT3 Liaison Report. The Presentation is attached as filename: C63 main (SC8 10-22-09) includes membership.ppt A report on the progress on a technical information report on the use of wireless devices in health care facilities was also presented.

7. FCC Matters focusing on relation to C63® activity – Bill Hurst

Review of FCC references to C63® standards – Mr. Hurst presented recent Notices on DTV converter box certification. The FCC Office of Engineering and Technology (OET) is seeking comment on recognizing accreditation bodies and ACLASS applications for

Recognition. There was a discussion on asking the FCC to reference C63.4-2009 and C63.5-2006. A "Public Notice" may be issued to allow the use of these new Standards. AI-9: Heirman and Camell to provide guidance document to the Commission on the choice of using various editions of C63.5, including 1988, 1998 & 2006 versions.

- **7.2 Status of FCC biennial review** –No report other than there are still no resolutions from all the comments submitted including those of C63®
- New projects needed by FCC to be considered by C63® include Broadband initiatives, plans for updating the FCC web presence and long-term changes to Equipment Authorization (EA) web pages. A new list of Draft Publications was shown and a Draft Presentations list was delivered, EA trends were presented, including increasing use of Telecommunications Certification Bodies (TCBs). The FCC presentation attached as filename: FCC Status Rpt Oct 2009.ppt The Main Committee decided to allow the Steering Committee to comment on these FCC filings as long as it is reported that such a filing is being drafted, allowing two weeks for any comments by C63® members. The Main Committee agreed to then allow the Steering Committee to submit such filings. Member companies are encouraged to provide copies of their related filings on that topic to the C63® steering committee.

8. "State of the Committee" review

- **8.1. Items of interest**--Chair/Secretary Nothing of special interest reported
- **8.2. Steering Committee Report** The Chair reported that the Steering Committee evaluated our web site Standards Status pages with a simplified update coming soon. Our organization membership representatives now have a procedure for the addition of alternate representatives, some operational procedures were amended, the current PINS and PINS-C were evaluated and the IEEE contract was reviewed. The schedule for our April 2010 meeting was set and is attached as filename: C63 April 2010 Meeting Schedule.doc
- **8.3. Website use and updates**-Secretary/Archambeault/Hare Mr. Hare reported that our Standards Status Matrix is out of date and a simplified, updated version was shown. (Attached as filename: SubCommittee Stds status template.xls which will be populated and uploaded to the site) Other recent updates to the site were also shown.
- **8.4. Status of C63® published standards**—Secretariat— (IEEE, Mike Kipness) Mr. Heirman reported that 4 and 10 year old Standards must be considered to keep our ANSI accreditation.

8.4.1 Fourth Anniversary standards

Mr. Kipness sent a table of these older Standards; C63.011, C63.022, C63.16, C63.6, C63.13, and C63.16. $\overline{\text{AI-10}}$: Chair to forward the Kipness e-mail to the Secretary to check the C63.12 date for accuracy. C63® is only interested in standards which are within 1 year of 5 years with no amendment activity and those close to the 10 year administrative withdrawal time

 - **8.5.1 Plans for updating C63® procedures**—Kesselman Mr. Heirman reported that no action is required until 2010.
 - **8.5.2 Plans for updating time sensitive tasks**—Kesselman Mr. Heirman reported that some tasks/actions had no time limit, but it was felt that "as soon as possible" shall mean less than 4 weeks. 9. C63® Legal matters--Chair

9.1 Trademark registration completed. AI-12: Secretary to post trademark booklet to our web site. Mr Heirman reports that our trademark registration is now complete: **C63**[®]

9.2 Legal support available Mr. Heirman reports that we only spent the equivalent of about \$3K out of a \$10K pro bono budget this year with its attorneys from Fish and Richardson.. The chair has been alerted that there will be a reduction in this amount that F&R can provide in the future.

10. Old Business

- 10.1 Action item review on items not covered elsewhere on Agenda including the action items from previous meetings in 2008—Secretary (closed) Mr. Hoolihan showed the Fifth Draft of our organizational membership "clarification," which is now complete after editing by the Steering Committee. The primary representative now has default voting rights. The document is attached as filename: FIFTH-DRAFT Membership Organization Clarification[1].doc. This was voted an approved.
- **10.2 Report of IEC CISPR 2010 meeting support**—Mr. Heirman reports that we're about **§19K short** of our contribution to support the meetings. Support of <u>Organizational Members</u> is sought.

- **11.1 Future Seminars and Workshops and MOUs with iNARTE**—Chair Mr. Heirman reported on our upcoming C63.10 workshop, detailed in the attached C63_10Workshop_updates.html. An MOU exists between C63® and iNARTE, so a second workshop may be held in May or mid-June, 2010, at UL in Northbrook IL,. C63.4 and C63.5 workshops will be held at the EMC Symposium in Ft. Lauderdale next year. Site validation workshops are being planned on C63.25 and C63.18 and C63.24 for on-site product testing. - 11.2 Newsletter report—Mr. Heirman reported that Mr. Kesselman shall publish the newsletter within 60 days of the Main Committee meeting and that the SC chairs should provide information in a "timely way."
