Approved Meeting Minutes

ANSI-Accredited Standards Committee C63 Electromagnetic Compatibility SUBCOMMITTEE 2 – E3 Terminology Definitions and EMC Best Practices

Wednesday, 29 September 2020, 1300 to 1430 ANSI C63[®] WebEx

- 1. <u>Call to Order.</u> Mr. Chris Dilay, SC2 Vice-Chairman, called the meeting to order.
 - 1.1. **Opening Remarks:** Mr. Dilay welcomed everyone noting that he would be running the meeting in the absence of the Chair, Mr. Marcus Shellman, who was unable to attend.
 - 1.2. <u>Meeting Logistics Announcements:</u> He addressed meeting arrangements and for the WebEx.
 - 1.3. <u>Introductions</u>: The Secretary conducted the roll call to record SC2 membership attendance and determine the establishment of a quorum. The meeting attendee list appears in Attachment 1.
 - 1.4. **Quorum:** Based on the number of SC2 member attendees, the Secretary determined that a quorum had not been met. It was determined that the meeting should proceed with any motions or votes taken deemed informal unless additional members join the meeting to satisfy quorum requirements.
- 2. <u>Review and Adoption of the Agenda</u>. Mr. Dilay presented the agenda, highlighting key areas of significance for the meeting. Motion to approve the agenda as written was passed by voice vote. See Attachment 2. The approved agenda will be provided to Jerry Ramie. (see Action Item 20200929 -1)
 - 2.1. Approval of the Previous Minutes: Mr. Dilay displayed the previously approved minutes of the SC2 meeting held on 24 June 2020 via WebEx. Mr. Hoolihan noted that a report in the June minutes that Mr. Stephen Berger should be removed from the roster as SC8 Chair was premature. Mr. Berger has recovered from his illness and resumed his role with SC8. Mr. Dilay made the immediate change to the SC2 roster in the agenda to reflect the update.
 - 2.2. Review of the Patent Slides: The C63® Patent Policy slides were not available for review. In their absence Mr. Hoolihan and Mr. Dilay discussed the patent rules and solicited information from attendees about any knowledge

of patent related issues. There were no objections to the patent policy, nor issues raised

3. Review of Subcommittee Membership.

- 3.1. <u>Membership.</u> Mr. Dilay displayed the SC2 membership, inquiring as to whether the chair of SC3 still remains vacant in Don Heiman's absence. Mr. Hoolihan stated that Ross Carlton, ETS Lindgren has been voted in as Vicechair of SC3. Mr. Dilay took the action to provide Jerry Ramie with the needed membership list changes. (See Action Item 20200929-2)
- 3.2. <u>Members at Risk.</u> The Vice-chair displayed the Member Attendance Log, which highlights members at risk. He noted that there are no members at risk at this time
- 3.3. Consideration of new members. The Vice-chair addressed the consideration of new members for SC2 stating no new applications for membership have been received. No new members have been added to the SC2 roster at this time. He did note, however, that changes previously submitted for the update of the WG1 and WG2 areas of the C63[®] Website for C63.14 and C63.28 have not been implemented. He took an action to follow-up with Jerry Ramie. The SC2 membership list appears in attachment 3. (See Action Item 20200929-3)
- 4. <u>Approval of Membership, Scope and Duties.</u> The Vice-chair noted the SC2 Scope and Duties were approved at the 24 June meeting. No action is needed at this time.
 - 4.1 <u>Election of Officers.</u> While no action is required at this time, Mr. Dilay noted that the election of all SC2 officers will be due at the December meeting.

5. SC2 Status and Working Group Reports.

5.1. Working Group 1 Report. Mr. Duncanson provided an update of WG1 activities since the last meeting and provided an update to ballot activities for draft ANSI C63.14-20XX, "American National Standard Dictionary of Electromagnetic Compatibility (EMC) including Electromagnetic Environmental Effects (E3)." He updated the subcommittee on the status of the MEC review, stating that after a 22 July SC2 submission of responses to the IEEE review, SC2 is still awaiting a response from the IEEE. He took an action at the urging of Mr. Hoolihan to reach out to the IEEE editor, Lisa Perry to expedite obtaining the document's status. (See Action Item 20200929-4)

Mr. Duncanson proceeded to provide the status of SC2 Pre-Ballot coordination with other subcommittees on the terms and definitions in their draft standards. He

reported, in line with coordination efforts for the next update of .14, that SC2 has begun looking at drafting a new PINS. Mr. Hoolihan cautioned against creating the situation where the subcommittee has two active PINS on the same standard. Mr. Duncanson assured that this PINS is in the very preliminary stages and the current draft .14 will be published prior to establishing a new PINS. He reported on coordination with SC4 in the review of definitions in draft C63.30-20XX. Additionally, coordination is underway with SC5 on definitions from draft C63.24. Coordination is also anticipated with SC6 with definitions in draft C63.8. He concluded the report with a recap of draft .14 status and reiterated the publish date for C63.14, anticipated to be by the end of the calendar year.

5.2. Working Group 2 Report. Mr. Dilay provided a status update for draft ANSI C63.28-20XX," Best Practice Methodologies, Processes, and Procedures for Electromagnetic Compatibility (EMC)." He displayed the "Scope" and the "Purpose" of the document noting that these have not changed with the current version of the draft. He showed the WG2 membership as it appears on the C63[®] website and highlighted some affiliation changes. The status of Harry Hodes' participation is still in question at present. Mr. Dilay reported Harry has determined that NASA will not be supporting his continued C63[®] participation. He may decide to stay on as an individual member. He recognized Karen Burnham as a new member whose participation has been valuable to the WG. He also recognized Ross Carleton, who has been participating, but has not yet confirmed his desire to be a regular WG member.

Mr. Dilay went on to provide the status of draft C63.28. He stated that the focus of recent efforts has been on current revision 1.38. He reported that the WG had undertaken a detailed CRM review for the entire document and dispositions for all comments are being incorporated into new revision 1.4, the focus of which was a clean-up of the verbiage in the document as opposed to creating new content. The new version should represent significant progress over the previous versions. He anticipated the next draft will be available for the next WG2 meeting scheduled for 16 October.

He stated the document currently consists of 11 clauses, 9 in progress with initial drafts that are included in the latest revision, and 2 that still require initial drafts or significant input prior to inclusion in the document. He displayed the table of contents of the standard and addressed the areas in the draft where assistance is still needed, focusing on the sections addressing "Product EMC Design Considerations," Test Instrumentation," and Annex B which addresses results of the SC3 International Standards Comparison Study and from whom additional comparison results were

expected by this time. He anticipates working closely with Ross Carleton to obtain the needed comparison studies.

Mr. Dilay concluded his report reiterating the need for volunteers to assist in the development of several sections and the need for subcommittees to provide inputs for each published standard as applicable to various sub-clauses of the document.

5.3. ASC-C63® Subcommittees & EMC Standards Projects. Mr. Dilay addressed the table in section 5.3, recently updated in accordance with comments from the last meeting and inquired of the need for any additional changes. Mr. Hoolihan wondered if C63.32 should be added to projects under SC8. Mr. Dilay took an action to reach out to SC8 for confirmation. Mr. Duncanson asked about the status of C63® standards page on the C63® website and whether it had been updated recently. He took an action to address the inquiry to Jerry Ramie. (See Action Items 20200929-5 and 6)

6. Other Old Business.

- 6.1 <u>Written Reports</u> Mr. Dilay inquired as to whether there are plans to publish the C63[®] Newsletter in the near future. Mr. Hoolihan stated that's a subject he intends to address at the October Steering Committee meeting. At present plans are to publish a Newsletter by the end of the calendar year.
- 6.2 <u>Coordination with SC2 for definitions</u> Mr. Hare raised the issue of SC5 coordination with SC2 regarding draft C63.24. He noted confusion in the way some SCs interpret their responsibility to coordinate definitions. In the case of .24, he cited instances of definition wording slightly different from what is existing in .14 creating a variety of similar definitions where only the one established should be used. He urged SC2 to address .24 discrepancies in the ballot process, time permitting. Mr. Hoolihan agreed citing confusion about the responsibility to "coordinate," versus gaining approval. He stated this is another topic he intends to address at the upcoming Steering Committee meeting.

- 8. <u>C63[®] SC2 Website Status.</u> Mr. Dilay stated that the SC2 member website would be brought up to date following this meeting.
