 - 3.2. The chairman reviewed the standard IEEE Patent Policy as required.
- 4. Review and Adoption of Minutes of Previous Meeting:
 The SC2 meeting minutes from 21 April 2010, held at IEEE Headquarters, Piscataway,
 NJ, were reviewed and approved. The minutes will be forwarded to Mr. Chris Dilay and
 Ms. Shannon Archambeault for posting onto the ASC C63® website.
- 5. Membership Review
 - 5.1. The membership roster was reviewed. No changes were noted.
- 6. Working Group Report:
 - 6.1. Review of the revised Scope:
 - 6.1.1 Subcommittee members reviewed ASC C63 Scope statement as approved by the Main Committee.
 - 6.2. ANSI C63.14 Update:
 - 6.2.1 Mr. Shellman reported that the draft C63.14-2009 PINS was submitted to Mr. Kipness for IEEE review during the ASC C63 Main Committee meeting of 23 April 2010. He subsequently contacted Mr. Kipness for an updated status but has yet to receive a response. Mr. Heirman took an action to contact Mr. Kipness to determine the status of the PINS.

6.3. Terms / Definitions:

 - 6.3.1.2 Broadband Device
 - 6.3.1.3 Broadband Emission
 - 6.3.1.4 Broadband Measurement
 - 6.3.1.5 Specification
 - 6.3.1.6 Standard
 - 6.3.1.7 Recommended Practices
- 6.3.2 Mr. Shellman noted that comments were received from Mr. Hofmann and Mr. Heirman. Discussion ensued regarding Mr. Heirman's comments. As a result of the discussion, Mr. Shellman took an action to rescope the definitions and then resubmit to the committee members for review.
- 6.3.3 Mr. Shellman brought to the group's attention that the Department of Homeland Security was seeking inputs to revise definitions for Software Defined Radios, Cognitive Radios, and Dynamic Spectrum Access. Mr. Moongilan accepted an action to provide the FCC definitions of the above terms.
- 6.3.4 Mr. Shellman briefly addressed the IEV Harmonization matrix being developed by Mr. Southworth. He recommended that the action be tabled until Mr. Southworth can address his methodology and findings.
- 6.3.5 Mr. Hofmann asked the committee to take an action to develop/review definitions for the terms "video display" and "monitor" to address the distinction between the terms as used in ASC C63.4. Mr. Hofmann will forward additional information including a draft of the standard and a presentation given at the SC1 meeting.
