SUBCOMMITTEE 2 – E3 Terminology Definitions

- 1. <u>Call to Order.</u> Mr. Marcus Shellman, SC2 Chairman, called the meeting to order.
 - 1.1. Opening Remarks: The chairman welcomed everyone to the meeting.
- 2. <u>Review and Adoption of Agenda</u>. The agenda was approved with one change by the Chairman to review the SC 2 Scope. See Attachment 2.
- 3. **IEEE Patent Policy.** The standard IEEE Patent Policy was reviewed as required.
- 4. Attendance Fee Slides. All SC2 members were found to be in good standing.
- 5. Membership Review.
 - 5.1. The SC2 membership list that was approved at the last meeting and subsequently updated on the C63 website was presented. No members were found to be at risk.
 It was noted that the addition of Dave Southworth to the SC2 and WG1 membership needs to be added to the website.
 - 5.2. The membership list was approved. The list appears in attachment 3.
- 6. <u>SC2 Scope</u>. The chairman presented the SC 2 Scope, which had been modified to address a needed text change. It was noted that a typographical error exists on the Scope, as published on the C63 website. The Chairman will request a correction via email to the C63 Webmaster.
- 7. **Review and Adoption of Minutes of Previous Meeting**. The chairman called for a review of the SC2 meeting minutes for the meeting held at IEEE Headquarters, Piscataway, NJ. on 07 May 2013. The minutes were approved without changes. The minutes will be forwarded to Mr. Ed Hare for posting onto the ASC C63[®] website.

8. Working Group 1 Report.

8.1. The Chairman provided the WG1 report, noting that the WG has reached the point where the five year review is draft ANSI C63.14 is completed and ready for publication. He addressed the balloting process and the procedures obtaining approval to enter the process, noting that the draft had been distributed to all SC 2 members for review. Mr. Hoolihan instructed that the draft had to be

approved by vote by SC 2 for consideration by the full C63 Committee prior to entry into the balloting process. Two motions followed the discussion, both of which were passed by voice vote.

- 8.1.1. Mr. Heirman made a motion for SC 2 to recommend to the main committee that draft ANSI C63.14 be reviewed in preparation for balloting.
- 8.1.2. Mr. Dilay made a motion to recommend to the main committee that after review of the draft, the committee makes a recommendation to the IEEE Secretariat that a balloting group be formed.
- 8.2. The Chairman deferred to Mr. Southworth to initiate a presentation on the aggregate changes reflected in draft ANSI C63.14 and how members should interpret the changes as provided in an Excel spreadsheet document distributed to SC 2 members for review and concurrence.
 - 8.2.1. He displayed the spreadsheet and went through the list of terms detailing the process used to adjudicate military standard and C63 standard terms and definitions.
 - 8.2.2. He displayed the 5 year review schedule to show the timeframe for the balloting and approval process, noting that the subcommittee is on schedule to meet the projected 2014 update.
 - 8.2.3. The Chairman addressed the adjudication of terms and definitions recommended by SC 2 members, or other organizations. He displayed the list of terms that have been added to the draft and explained the WG 1 process for review, acceptance or modification of new definitions, and subsequent review and concurrence from SC 2 members.
- 9. <u>Status of the SC2 Website.</u> Mr. Dilay provided a report on the status of the SC 2 Webpage. He displayed the page, noting that it has been updated and that all of the latest documents have been added. During to action item review Mr. Heirman inquired about the entry on the historical ANSI C63.8 standard, which was never published. It was determined after discussion that Mr. Dilay had properly updated it to clarify the rationale for keeping the standard there. It was noted that the "C63.8" number is available for use on a new C63 standard.
- 10. Old Business none.
- 11. <u>New Business.</u> Mr. Southworth recommended the initiation of a task to develop a C63 "Best Practices" document to address EMC best practices. Discussion followed on the relevance of the topic, and whether such an undertaking would fit within the SC 2 Charter. On recommendation from Mr. Hoolihan, Mr. Southworth took an action to develop a PINS for the development, to work out details of the focus and intended users.
