SUBCOMMITTEE 2 – E3 Terminology Definitions

- 1. Call to Order. Mr. Marcus Shellman, SC2 Chairman, called the meeting to order.
 - 1.1. Opening Remarks: The chairman welcomed everyone to the meeting.
 - 1.2. <u>Meeting Logistics Announcements:</u> Mr. Hoolihan addressed meeting arrangements for the afternoon sessions.
 - 1.3. <u>Introductions</u>: The chairman called for a round of introductions from meeting attendees. The attendee list appears in Attachment 1.
- 2. **Review and Adoption of Agenda.** The agenda was approved as written. See Attachment 2.
- 3. **IEEE Patent Policy.** The standard IEEE Patent Policy was reviewed as required.
- 4. **Attendance Fee Slides.** All SC2 members were found to be in good standing.
- 5. Membership Review.
 - 5.1. The SC2 membership list that was approved at the last meeting and subsequently updated on the C63[®] website was presented. No members were found to be at risk. The list appears in Attachment 3.
 - 5.2. Mr. Tom Wojtaszek was introduced by the chairman as a proposed new member. After presentation of his resume and discussion by the subcommittee he was accepted as a new SC2 member by voice vote.
 - Mr. Shellman, noting that his two terms as chairman of SC2 ends this year, initiated actions to nominate new officers for SC2. Mr. Dilay, current Web Coordinator of SC2 was nominated to be the new SC2 Chairman. Mr. Shellman was nominated to be Vice Chairman. Mr. Duncanson was nominated to continue as SC2 Secretary. All nominations were accepted by voice vote.
- 6. <u>Review and Adoption of Minutes of Previous Meeting</u>. The chairman called for a review of the SC2 meeting minutes from the meeting held at ETS Lindgren, Austin, TX on 29 April

2014. The minutes were approved without changes. The minutes will be forwarded to Mr. Jerry Ramie for posting onto the ASC C63[®] public website and SC2 member webpage.

7. <u>Action Item Review.</u> Action items from the previous meeting were reviewed and resolved as shown below:

8. SC2 Status and Working Group Reports

- 8.1. **Revised SC2 Scope**. The chairman presented the SC2 Scope, which was revised to address the new Best Practices project. He noted the revised Scope was not reviewed at the last C63[®] Main Committee meeting because of comments received at the previous SC2 meeting. The revised Scope was approved with one additional recommended change and balloted to be presented to the C63[®] Main Committee for approval.
- 8.2. Working Group 1 Report. Mr. Shellman provided the status of draft ANSI C63.14-2014, stating that the standard is undergoing BSR 9/IEEE Editor review, with the proof copy currently being evaluated by WG1. There was discussion about the approval process, editorial recommendations and copyright issues, Mr. Shellman noting that a number of the seemingly minor suggested editorial changes, such as changing verbiage from a "which" to a "that," would actually impact a number of copyright protected definitions. Mr. Hoolihan emphasized that the suggested editorial changes should be taken as suggestions and should be rejected if they would result in an inappropriate change in a definition. Mr. Shellman stated plans are to accept the proof to move forward to publication, with a few minor edits as discussed, to ensure the integrity of the definitions. Publication of the standard is anticipated to occur by 31 December 2014.

- 8.2.1. Mr. Shellman presented the SC2 review process for including definitions in the next revision of C63.14-20XX, highlighting procedures for addressing terms from Military standards, C63[®] standards, and those developed by C63[®] committee. He displayed a flow diagram illustrating the definition approval process.
- 8.2.2. There was significant discussion concerning the approval process for C63[®] standards, the chairman noting that the review of draft C63.26-20XX, currently underway by WG1, has revealed a number of proposed definitions that are very close to definitions already existing in draft C63.14-2014. He emphasized the importance of C63.14 review by all subcommittees as definitions are being developed, to avoid the inclusion of duplicative definitions in future iterations of the standard. Mr. Heirman noted that SC2 should be able to determine that a proposed definition is satisfied by one that already exists in C63.14. He requested and Mr. Shellman accepted an action to forward C63.26-20XX proposed terms and definitions to all SC2 members for review. Additionally, he suggested a meeting be convened via WebEx to address results. (See Action Item 12-1)

8.3. Working Group 2 Report: Best Practices Guide

- 8.3.1. The chairman reported that the PINS for development of ANSI C63.28-20XX, "American National Standard Dictionary for Best Practices for Electromagnetic Compatibility," had been approved at the last C63® main committee meeting in Austin, TX. Mr. Heirman noted, however, that because of the change just initiated by the subcommittee in the SC2 Scope, an additional change is needed in the C63.28 PINS, for consistency. It was determined after discussion that a change could be made in the wording of the PINS without the need for additional concurrence from the C63® main committee, so long as the change didn't impact stakeholders. Mr. Shellman took an action to modify the C63.28 PINS for consistency with the change in the SC2 Scope. (See Action Item 12-2)
- 8.3.2. Mr. Shellman addressed considerations for WG2 membership and appointment of a chairman. He made the appointment of Mr. Dilay to be the chairman of the WG. He then asked for a show of hands of meeting attendees interested in joining WG2 for the development effort. Based on the initial response, WG2 currently consists of the following membership: Dan Hoolihan, Don Heirman, Ken Carrigan (observer), Tom Wojtaszek, Mike Duncanson, and Marcus Shellman.
- 8.3.3. The chairman addressed the current development approach for ANSI C63.28-20XX, noting the history and participation by the ANSI C63.® in the initial Defense/Industry standards comparative study completed in 1990, which compared major international EMC standards to MIL-STD-461E. Mr. Dilay elaborated on the current approach stating that one goal of the effort is to aid commercial manufacturers by aligning specific categories of equipment with the appropriate MIL-STD compliance test requirements. With regard to actual standards comparisons, SC2 has concluded that the basic approach established

with the initial effort still holds true, greatly facilitating the work to be done. Test frequency ranges, limit levels and test set-ups/methodologies will provide the basis for comparisons. Updated commercial/international EMC compliance standards will be identified for comparison to upcoming MIL-STD-461G, anticipated to be issued in the spring of 2015. In the course of the discussion Mr. Heirman offered that he could provide current information on commercial product development and applicable EMC standards. He took an action to provide the data to Mr. Dilay. (See Action Item 12-3)

- 9. <u>SC2 website maintenance</u>. Mr. Dilay provided a report on the status of the SC 2 Webpage. He displayed the password protected page, noting that it has been updated and that all of the latest documents have been added. The chairman appointed Mr. Wojtaszek to the position of SC2 Web coordinator to fill the vacancy left by Mr. Dilay, who will be assuming chairmanship of SC2.
- 10. <u>Coordination with other C63 subcommittees on terms/definitions</u>. The chairman briefly recapped pertinent aspects of the working relationship between SC2 and the other subcommittees to develop definitions noting the work currently being done on draft ANSI C63.26-20XX.
