1. **Call to Order.** Mr. Marcus Shellman, SC2 Chairman, called the meeting to order.
 - 1.1. **Opening Remarks:** Mr. Shellman welcomed members to the meeting.
 - 1.2. **Meeting Logistics Announcements:** Meeting was held virtually and in-person.
 - 1.3. **Introductions:** Mr. Duncanson, SC2 Secretary conducted the roll call to record SC2 membership attendance and determine the establishment of a quorum. The meeting attendee list appears in Attachment 1.
 - 1.4. **Quorum:** Based on the number of SC2 member attendees, the Secretary determined that a quorum had been met.
2. **Review and Adoption of the Agenda.** Mr. Shellman called for a review of the agenda, highlighting key areas of significance for the meeting. A motion to approve the agenda was passed by voice vote. The approved agenda appears as attachment 2.
 - 2.1. **Approval of the Previous Minutes:** Mr. Shellman called for a review of the minutes of the previous meeting. He stepped through minutes of the SC2 meeting held on 03 October 2024 at Google Headquarters, Mountain View, CA, addressing areas of significance. A motion to approve the minutes of the October meeting was passed via voice vote. The approved agenda and minutes will be provided to Jerry Ramie for posting to the C63[®] website. (See Action Item 20240515 - 1)
 - 2.2. **Review of the Patent Slides:** Mr. Shellman presented the C63[®] Patent Policy slides and polled attendees with respect to knowledge of patent related issues. There were no affirmations of patent issues or objections to the patent policy.
3. **Review of Subcommittee Membership.**
 - 3.1. **Membership.** Mr. Shellman displayed the SC2 membership as it appears on the C63[®] website.

- 3.2. **Members at Risk.** There were no members at risk.
- 3.3. **Consideration of new members.** Mr. Shellman noted that no new applications for membership have been received since the last meeting. The SC2 membership list appears as Attachment 3.
4. **Display of SC2 Scope and Duties.** Mr. Shellman displayed the SC2 Scope and Duties. A motion to approve the SC2 Scope and Duties was passed via voice vote by the members.
 - 4.1 **Election of Officers.** Mr. Shellman was reappointed as the SC2 Chair during an email ballot in December 2023. Mr. Duncanson was reappointed as the SC2 Secretary. The SC2 Vice Chair position is vacant. A motion to approve the SC2 Officers was passed via voice vote by the members.
5. **SC2 Status, Working Group Reports and C63® Standards Projects.**

5.1. **Working Group 1 Report.** Mr. Duncanson provided an update of WG1 activities since the last meeting. He reported that the draft C63.14 had undergone IEEE editorial review and WG1 has adjudicated all comments. IEEE has generated final proofs and publication is anticipated by early June 2024.

Mr. Duncanson continued the WG1 report with the SC2 coordination status with other subcommittees, presenting an overview of pre-ballot reviews conducted during 2023. He displayed draft standard reviews by version number and provided status, noting that in most cases more than one review took place to resolve specific issues. The reviews involved C63.4, C63.9, C63.16 and C63.26. Coordination is ongoing with respect to C63.26 and C63.16.

Mr. Duncanson concluded the report with a brief discussion on copyright release procedures, continuing a discussion initiated at the last meeting. WG1 recommends consideration of a change to C63 procedures, to have the IEEE Secretariat automatically include copyright release requests for draft C63.14 when obtaining releases for definitions for use in other C63 standards. There was consensus that this would be a commonsense procedures addition.

5.2. **Working Group 2 Report.** Mr. Shellman reported that WG2 is remains inactive so that report is tabled at this time.

5.3 **C63® Subcommittees & EMC Standards Projects.**

Mr. Shellman displayed the active status of C63® standards projects as maintained on the SC2 Agenda and inquired of the group to identify any needed updates. While no discrepancies were identified, there was discussion and agreement that all standards related projects, including corrigenda, interpretations, etc. should be addressed in this section. The section will accordingly be updated.

6. **Other Old Business.**

6.1 **Written Reports** - Mr. Shellman stated that the SC2 meeting report will be prepared for the Main Committee meeting.

6.2 **Coordination with SC2 for definitions** - Mr. Shellman reiterated the SC requirement for timely actions for coordination with SC2 on their terms and definitions.

6.3 **Coordination with SC3 for Harmonization** - Mr. Shellman noted the responsibility of all subcommittees to coordinate with SC3 as well, for international harmonization.

7. **New Business.** None.

8. **C63® SC2 Website Status.** Mr. Shellman reported that updates to the SC2 Website have been initiated with the assistance from Jerry Ramie (Action Item 20240515-3). He anticipates having the site up to date prior to the next meeting.
