- 1. Call to Order:
 - 1.1. Opening comments: Mr. Marcus Shellman, SC2 Chairman, called the meeting to order.
- 2. Self introduction of participants: Participants are identified in Attachment 1.
- 3. Review and Adoption of Agenda:
 - 3.1. The agenda was approved without changes. See Attachment 3.
 - 3.2. The chairman reviewed the standard IEEE Patent Policy as required.
- 4. Review and Adoption of Minutes of Previous Meeting:
 The SC2 meeting minutes from October 2009, held at NIST, Boulder, Co. were reviewed and approved. The minutes will be forwarded to Mr. Chris Dilay and Ms. Shannon Archambeault for posting onto the ASC C63® website.
- 5. Membership Review
 - 5.1. The membership roster was reviewed. The chairman noted that the previous SC2 Secretary will continue as a member, but will no longer be travelling to the meetings.
 - 5.2. Mr. Michael Duncanson was nominated for membership and to fill the position of SC2 secretary. His nomination was unanimously approved by SC2, pending receipt of the formally required documentation for membership, and will require confirmation by the C63[®] main meeting on 22 April 2010.
 - 5.3. The proposed revised SC2 membership is shown in Attachment 2.
- 6. Working Group Report:
 - 6.1. Review of the revised Scope:
 - 6.1.1 Subcommittee members reviewed and discussed the wording of the revised Scope. Minor changes to the wording were recommended.
 - 6.1.2. The Scope was voted on and approved with recommended changes.

6.2. ANSI C63.14 Update:

- 6.2.1 Subcommittee members reviewed and discussed the wording of the C63.14-2014 Draft PINS.
- 6.2.2 The Draft PINS was voted on and approved with a recommended change to section 5.0.

6.3. Terms / Definitions:

- 6.3.1 Mr. Shellman provided the status of the effort to develop new definitions. Currently under consideration are the terms "Broadband System," and "Standard."
- 6.3.2 Mr. Shellman indicated that the definitions are still under development. He noted that there are currently three variations for the definition of "Standard" under consideration.
- 6.3.3 He proposed a new action for SC2 members to review and provide recommendations for the definitions. A 1 June suspense date was decided upon for member recommendations.
- 6.3.4 Mr. Hodes noted widespread confusion in commercial industry concerning the distinction in terminology between a "standard," and a "specification." He recommended that "specification" be added to the list of new definitions for development, with a goal of making the distinction between the two terms clear. It was agreed that the definition for "specification" will be added to the list of definitions in C63.14.
- 6.3.5 Mr. Heirman addressed the need for coordination between all subcommittees and SC2, to track definitions for terminology used in all C63[®] standards. He proposed an action item for all subcommittee chairs to provide definitions used in their standards, or draft standards to SC2. Mr. Shellman will draft the action item and send to all subcommittee chairs.
- 6.3.6 Mr. Heirman took an action to develop a template for asking permission for C63[®] use of definitions from copyrighted sources.

7. Old Business:

- 7.1. Attribution Process Mr. Southworth has completed the action to draft a White Paper on the C63.14 Attribution Process. Mr. Snyder will forward to the C63[®] Secretary along with the draft PINS.
- 7.2. Website Status Mr. Shellman reported that the SC2 Website is up to date. He noted that Mr. Dilay will send out a link to the site and a password to SC2 members for access.
- 7.3. IEV Harmonization Mr. Shellman reported that he had responded not to accept Mr. Anderson's (SC3) proposal to merge C63.14 with the International Electrotechnical Vocabulary. He cited several reasons in his rationale for rejection of the proposal, chief among them being the fact that C63.14 is referenced by DoD standards. He indicated he has not yet received a response from Mr. Anderson.

8. New Business:

A summary report announcing SC2 initiation of the 5 year revision of C63.14 (due in 2014) has been sent to Warren Kesselman to be published in the ANSI ASC C63[®] Newsletter.

9. Action Item Review:

- 9.1. SC2 members to review and provide recommendations for the definitions currently under consideration. Recommendations due by 1 June 2010.
- 9.2. Mr. Shellman to add, "Specification" to the list of C63.14 definitions for review, to ensure clarity of the distinction between a "standard" and a "specification."
- 9.3. Mr. Shellman to draft an action item for all subcommittee chairs to provide a list of all definitions used in their standards, or draft standards, to ensure consistency with C63 14
- 9.4. Mr. Heirman to draft a template for asking permission for C63[®] use of definitions from copyrighted sources.
- 9.5. Mr. Dilay will arrange for the following data to be uploaded to the C63® web site in concert with Ms. Shannon Archambeault to include:

The approved membership roster

The approved draft PINS

The approved SC2 Scope

The draft minutes of this meeting and notify members of posting.
